- 2. <u>SWEEPSTAKES PERIOD</u>. The Sweepstakes begins at 12:00:00 AM Eastern Time ("ET") on October 31, 2018 and ends at 11:59:59 PM ET on November 30, 2018 ("Sweepstakes Period"). Promotion Activator's computer is the official time keeping device for entry into the Sweepstakes.
- 3. <u>ELIGIBILITY</u>.
